

## REAL ID DOCUMENT REQUIREMENTS

According to [W.S. 31-7-111](#), to be issued a Wyoming Driver License or Identification Card, you must prove the following: your full legal name, identity, age and lawful presence in the United States. Below is a list of acceptable documents to comply with this requirement. **NOTE: You must present one or more documents from each of the three (3) sections below.**

<b>SECTION 1: Proof of Identity (<i>must present <u>one</u> of these documents</i>)</b>	
<b>NOTE: All documents presented must be certified originals or certified amended originals or true copies certified by the issuing agency.</b>	
U.S. Birth Certificate**	Legal proof of a name change is required if your name is now different than the one on your birth certificate ( <b>see Proof of Name Change</b> ).
Valid U.S. Passport (unexpired)**	Legal proof of a name change is required if your name is now different than the one on your Passport ( <b>see Proof of Name Change</b> ).
Consular Report of Birth Abroad	Form FS-240, DS-1350 or FS-545
Certificate of Citizenship	Form N-560 or N-561
Certificate of Naturalization	Form N-550 or N-570
Valid Permanent Resident Card	Form I-551
Valid Employment Authorization Document (EAD)	Form I-766 (Not all EAD card holders are eligible to be issued a Wyoming Driver License or Identification Card)
Valid Foreign Passport	Form I-94 - When affixed with a U.S. Visa and accompanied by an approved document documenting the applicant's most recent admittance to the United States. (Not all valid foreign passport holders are eligible to be issued a Wyoming Driver License or Identification Card)
State Issued Driver License or Identification Card	Must comply with the new federal security requirements Wyoming began enforcing on June 1, 2011. (This would be the state issued license or ID card with the "gold star").

<b>SECTION 2: Proof of Current Residence (<i>must present <u>two</u> of these documents</i>)</b>		
<b>NOTE: The documents must contain <i>your</i> name and current physical address (not a PO Box number). For a minor child, a parent/guardian may provide the proof of residence in the parent/guardian name.</b>		
Utility Bill	Credit Card Statement	Pay Stub or Earnings Statement
Rent Receipt	Telephone Bill	Transcript or Report Card
Bank Statement	Mortgage Document	Tax Document
Insurance Policy	Vehicle Registration or Title	Voter Registration
Other items with address that can be reviewed by Driver Services Examiner		

<b>SECTION 3: Proof of Social Security Number (<i>must present <u>one</u> of these documents</i>)</b>	
Social Security Card	A photo copy is <u>not</u> acceptable
Bank Statement	If the statement includes the SSN number
W-2 Form	
Other legal or government document displaying <i>your</i> name and SSN number that can be reviewed by Driver Services Examiner	

<b>**Proof of Name Change</b>
Legal proof of a name change is required if your name is now different than the one on your "Proof of Identity" document. Proof of name change may include: marriage certificate, divorce decree, court order, etc.
Other legal or government documents can be reviewed by Driver Services Examiner
