Starting Jan. 30, 2012,

the lowa Department of Transportation (DOT) will implement new federal regulations that require all CDL holders and applicants to certify the type of driving they do, and require interstate CDL holders that carry a Medical Examiner's Certificate to give the lowa DOT a copy of their certificate.

These new regulations DO NOT change who has to obtain a CDL or who has to obtain a Medical Examiner's Certificate. They only require two things:

- All CDL holders and CDL applicants
 must self-certify the type of driving
 they are engaged in. Use the inside
 of this brochure to determine your
 driving type.
- **Drivers that certify to nonexcepted interstate driving** must give the lowa
 DOT a copy of their Medical Examiner's
 Certificate, and must keep that certificate current.

WHEN DO I NEED TO COMPLY?

All CDL holders must complete the self-certification and provide the Medical Examiner's Certificate, if required, by **Jan. 30, 2014**. If you renew or change your CDL before Jan. 30, 2014, you will be required to comply at the time of the renewal or change.

What if I do not renew or change my CDL before Jan. 30, 2014?

You will need to complete the self-certification and submit the Medical Examiner's Certificate on or before that date, even though your CDL does not expire until later.

What happens if I do not comply?

The federal regulations require the lowa DOT to downgrade your CDL to a noncommercial license if you do not complete the self-certification of type of driving and submit the Medical Examiner's Certificate, if required, before Jan. 30, 2014.

Where and how do I do this?

- 1. Self-certify as a nonexcepted interstate driver.
- 2. Submit a copy of your Medical Examiner's Certificate to the lowa DOT.

Often a Medical Examiner's Certificate expires before it is time to renew your CDL. Be sure to keep a current Medical Examiner's Certificate on file with the lowa DOT. Failure to do so can result in a downgrade of your CDL status.

1. Self-certify as an excepted interstate driver.

Do you operate a CMV only?

- As a public utility truck per lowa Code 321.449
- As a truck hauling gravel per lowa Code 321.449*
- As a construction truck or equipment per lowa Code 321.449*
- As a truck moving implements of husbandry per lowa Code 321.449*
- As a special truck, other than a truck tractor per lowa Code 321.449
- · As a school district-employed school bus driver
- As a government driver per adoption of federal rules in 761 IAC 520

*Does not include truck-tractor semi-trailer combinations and trucks for hire



NONEXCEPTED INTRASTATE

- 1. Self-certify as a nonexcepted intrastate driver.
- You DO NOT need to submit a copy of your Medical Examiner's Certificate to the lowa DOT; however, you must carry it with you while driving.

HOW DO I COMPLY?

HOW DO I STAY IN COMPLIANCE?

Drivers that are required to submit a Medical Examiner's Certificate must submit a new certificate before the previous one expires to stay in compliance and avoid a downgrade of their CDL to a noncommercial license.

Once you have completed the initial self-certification and submitted your Medical Examiner's Certificate for the first time, submit new Medical Examiner's Certificates via one of the methods listed in the box to the left.
