Instructions for Montana residents who are *temporarily* out of the state of Montana and need to renew their commercial driver license (CDL) by mail.

- Renewals completed by mail are valid for five years.
- Your next renewal must be completed at a driver exam station within the state of Montana.

Note: You cannot renew a CDL that has a hazardous materials endorsement by mail, unless you choose to renew without the hazardous materials endorsement. You **must** renew at a field examination station within the state of Montana to keep the hazardous materials endorsement.

To renew your CDL by mail, you need to do the following:

- □ Complete and **sign** these three forms:
 - This Commercial Driver License (CDL) Mail Renewal Application
 - Report for Eye Examination Application-Form 3
 - CDL Self-Certification Classification and Medical Documentation form
- Include a photocopy of your current Medical Examiner's Certificate (MEC) (formerly known as a DOT card) and any accompanying waivers or variances. The MEC must be valid for 30 days or more. New federal regulations mandate that a commercial driver license be downgraded if a current MEC is not maintained with the Montana Motor Vehicle Division.
- □ Include a photocopy of two pieces of acceptable identification.
- □ Enclose a check or money order in the amount of \$50.50 for a Type-I CDL renewal or \$43.00 for a Type-II CDL renewal. Add an additional \$2.50 if you have a motorcycle endorsement and would like to retain it.
 - Note: If you are 71 years or older, please pay \$10.00 for a Type-I license and \$8.50 for a Type-II license for each year up to 75 years old and add \$.50 to the fee you are paying.
- □ Enclose one self-addressed, **stamped** envelope for the temporary copy to be mailed back to you. (It will take approximately 1 to 2 weeks to receive the temporary copy and 2 to 4 weeks to receive the permanent license.)

Note: Your application cannot be processed unless all of the above instructions are followed completely.

If you are a veteran and would like that designation on your CDL, Form 21-3000 must be submitted with this application.
